

Open Storage Business Operators of Recyclable Resources as of July 1, 2024

Enforcement of the ordinance pertaining to open storage of recyclable resources in Koshigaya City

○ Recyclable Resources / Materials

Includes metals, plastics, etc. from items that are no longer in use. However, municipal waste, electric appliances, plastic containers and tableware that can still be used are not included.

○ Outdoor & Open Storage Site

Refers to the place where business transactions are conducted such as the collection the process of crushing and smashing, sorting, packing and so on of materials that can be recycled, etc.

From July 1 to September 20, 2024

Business operators of an open storage recycling business as of July 1 must submit a notification that they have been operating an open storage site for the business.

From the date of the above notification until December 31

Make sure that the storage facility for recyclable materials meets the criteria or general requirements (mentioned on the reverse side), and process a notification of the structure, etc. of your open storage facility. Failure to process the necessary notification means unauthorized to do business and penalties may apply.

Criteria / general requirements of the storage site

- (1) A wall or fence must be set up around the storage site or facility.
- (2) An information board about the business facility must be set up on the site. (Fig. 1)
- (3) The storage site must be equipped with materials that are shatterproof and can prevent accidents; must be ready for sewage leakage; prevents infiltration into the ground; odor control, etc.
 - The wall/fence must be structurally safe for holding loads of recyclable materials

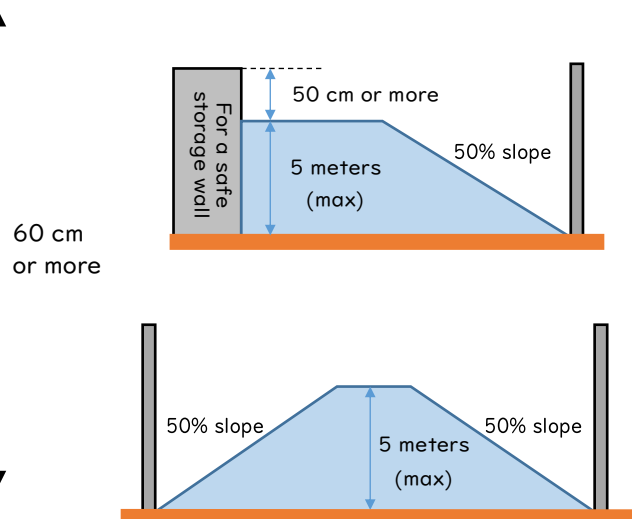


Fig. 2: Storage Height

 - When not using any container for the collected recyclable materials, the height of the loads must not exceed to the height of the wall or fence. (Fig. 2)
 - When there's a risk of water pollution caused by the open storage site, use impermeable materials that will prevent sewage generation of the area.
- (4) To prevent fire outbreaks and for fires from spreading, the site must be properly equipped and ready with the following:
 - Proper collection and disposal of materials that may cause fire.
 - Each block for the storage area must not exceed 200 square meters.
 - The distance between each storage area must be at least 2 meters if there's no fire wall that can protect the fire from spreading in case of fire.
- (5) The storage site must be ready to prevent loud noise and vibrations and other disturbances that may cause trouble to the people living within or close to the area
- (6) The storage site must be free from rats, mosquitoes, flies and other pests and bugs.
